September 2020 Monthly Report:

During the month of September, 2020, the Board of Claims received **36** negligence claims filed against the Commonwealth.

The Board rendered **15** decisions in claims *under \$2,500.00* in September, 2020 (*after the Board meeting with instructions*). Of those, **7** were dismissed and **8** were awarded for a total amount awarded of **\$6,935.59**.

At its meeting on September 22, 2020, the Board awarded **2** additional negligence claims in the total award amount of **\$11,681.17** and dismissed **2** other claims. Together with the claims under \$2,500.00, the Board decided **19** claims altogether while dismissing a total of 9 negligence claims and awarding a total of **10** negligence claims for a total amount awarded of **\$18,616.76** in September, 2020.
