Summary of Proposed Amendment of 802 KAR 1:010. Tax Appeal Procedures

- The amendment amends the procedures governing the Board of Tax Appeals.
- The amendment provides clarification for board staff, taxpayers, and taxing agencies regarding the procedures for appealing a tax assessment to the Board of Tax Appeals.
- The amendment clarifies when the time for filing an appeal begins, both to reduce confusion and the number of untimely actions filed, but also allows a taxpayer to prove the petition of appeal was timely when the documentation attached to the petition does not necessarily demonstrate timeliness.
- The amendment makes clear that all documents must be filed either in person or by private delivery, mail addressed to the board, or electronic mail.
- The amendment provides that a hearing officer may enter orders concerning prehearing disclosures.
- The amendment clarifies that the parties may file proposed findings of fact and conclusions of law, and it reduces the amount of time a party has to respond to a motion or pleading from thirty (30) days to twenty (20) days.
- The amendment also makes it clear that when a hearing officer rules on a dispositive motion which does not entirely dispose of the matter, the aggrieved party may request the board review the ruling within twenty (20) days of the order's issuance.
- When a party seeks judicial review, the amendment allows the board to file the official record of its proceedings on a thumb drive, as some circuit court clerks currently attempt to require the agency to file voluminous records in paper format.

•	The amendment incorporates by reference a subpoena form to be used by the board,
	hearing officers, and parties, and provides direction for issuing subpoenas.
