- 3. Executive Director's Report for March, 2008:

The Board of Claims received 184 new claims during the month of March, 2008. Of these, 101 were set up under \$1,000.00, 13 were set up under \$100.00, and seven (7) were set up over \$1,000.00, for a total of 121 new claims processed.

The Board awarded nine (9) claims for a total of \$21,557.83 at its March 21, 2008 meeting. Of these, seven (7) claims were decided by Agreed Order. There were also 15 claims dismissed by the Board at that meeting. Eleven (11) claims over \$1,000.00 were assigned to Hearing Officers in March.

Jackie Lynch reports that as of April 1, there were 125 active claims under \$1,000. She also reports that the number of claims under \$1,000 has increased significantly over the last month due to the large number of pothole claims. Jackie feels that it will be difficult to stay ahead of the deadline for the next several months with only one (1) nvestigator.
