Investigators Jackie Lynch and Wanda Luttrell decided 75 claims (under \$1000.00) in March, 2009. Forty three (43) claims were dismissed and 32 claims were awarded, for a total amount awarded of \$10,868.37.

Together with the claims investigated in-house, the Board dismissed a total of 83 claims and awarded a total of 40 claims for a total amount awarded of \$29,539.20 in March, 2009.
