The Board of Claims received 120 new claims during the month of March, 2010. A total of 109 claims were set up, according to Assistant Clerk Paula Woolums. Paula also dismissed 12 claims for being under the \$100.00 threshold and returned nine (9) claims for lack of jurisdiction.

Investigators Jackie Lynch and Wanda Luttrell decided 58 claims (under \$1,000.00) in March, 2010. Jackie reports that 45 claims were dismissed and 13 claims were awarded, for a total amount awarded of \$5,628.37.

At its Board meeting on March 18, 2010, the Board dismissed 24 claims and awarded eight (8) claims totaling \$133,602.59. Together with the claims investigated in-house, the Board dismissed a total of 69 claims and awarded a total of 21 claims for a total amount awarded of \$139,230.96 in March, 2010.
