April 19, 2012

The Board of Claims received 54 new claims during the month of March, 2012. A total of 75 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned three (3) claims for lack of jurisdiction.

Investigators Jackie Lynch and Wanda Luttrell decided 38 claims under \$1,000.00 in March, 2012. Jackie reports that 27 of these claims were dismissed and 11 were awarded, for a total amount awarded of \$4,156.56.

At its Board meeting on March 15, 2012, the Board dismissed 13 claims and awarded nine (9) claims totaling \$225,508.86. Together with the claims investigated in-house, the Board dismissed a total of 40 claims and awarded a total of 20 claims for a total amount awarded of \$229,665.42 in March, 2012.

The Executive Director reminded the Board Members to review cases as they are brought forward to ensure that the members do not have a conflict of interest. If there is a conflict with a claim, the Executive Director asked that the Board members state that they are recusing themselves from voting on that claim.
