Investigator Jackie Lynch decided 33 claims under \$1,000.00 in March, 2013. Jackie reports that 21 of these claims were denied and 12 were awarded, for a total amount awarded of \$5,118.02.

At its Board meeting on March 21, 2013, the Board dismissed 20 claims and awarded nine (9) claims totaling \$380,888.96. Together with the claims investigated in-house, the Board dismissed a total of 41 claims and awarded a total of 21 claims for a total amount awarded of \$386,006,98 in March, 2013.
