The Board of Claims received 70 new claims during the month of March, 2016. Paula reports that a total of 56 claims were set up and one (1) claim was returned for lack of jurisdiction.

Investigator Jackie Lynch decided 43 claims under \$1,000.00 in March, 2016. Jackie reports that 35 of these claims were denied and eight (8) were awarded, for a total amount awarded of \$3,082.99.

At its Board meeting on March 17, 2016, the Board dismissed 19 claims and awarded seven (7) claims totaling \$115,549.87. Together with the claims investigated in-house, the Board dismissed a total of 54 claims and awarded a total of fifteen (15) claims for a total amount awarded of \$118,632.86 in March, 2016.
