I. MARCH MONTHLY REPORT

During the month of March 2026, the Board of Claims received **147** negligence claims filed against the Commonwealth. The Board rendered **34** decisions in claims *under* \$2,500.00 in March. Of those, **21** were dismissed and **13** were awarded for a total amount of **\$7,025.52** in awards.

At its March meeting, the Board dismissed **2** claims via Motions; denied **2** Motions and assigned them to a hearing officer; dismissed **9** claims via Recommended Orders and *sua sponte* dismissals; and awarded **2** claims through Agreed Orders of Dismissal and adoption of Recommended Orders, awarding an additional amount of **\$12,094.51**. With the claims under \$2,500.00, and those decided at the March Meeting, the Board decided **50** claims, dismissing a total of **33** claims, and awarding a total of **17** claims for a total amount awarded of **\$19,120.03**.
