The Board of Claims received 54 new claims during the month of July, 2016. Paula reports that a total of 43 claims were set up and two (2) were returned for lack of jurisdiction.

Investigators Jackie Lynch and Angela Robertson decided 29 claims under \$1,000.00 in July, 2016. Angela reports that 15 of these claims were denied and 14 were awarded, for a total amount awarded of \$5,283.23.

At its Board meeting on July 21, 2016, the Board dismissed 20 claims and awarded nine (9) claims totaling \$49,816.86. Together with the claims investigated in-house, the Board dismissed a total of 35 claims and awarded a total of 23 claims for a total amount awarded of \$55,100.09 in July, 2016.
