NOVEMBER MONTHLY TOTALS

The Board of Claims received 76 new claims during the month of November.

54 claims could be processed. They are requesting a total of \$4,889,584.62.

The Board awarded 16 claims a total of \$31,358.98.

The Board dismissed a total of 49 claims that had requested \$25,964,740.05.

34 new claims were assigned to be investigated under \$1,000. Jackie and Wanda decided 32 claims during the month of November.

BACKLOG INFORMATION

As of the 3rd day of December Paula had 16 new claims waiting to be set up.

Jackie and Wanda had 11 claims that an answer had already been filed and needed a decision to be rendered. (However, none of the decisions are due out before December 15.)

Paula will have the claims set up by the end of this week and Jackie and Wanda are at least two weeks ahead. So it appears that the Board of Claims does not have a backlog.
