Minter

The Board of Claims received 22 new claims during the month of November, 2009. A total of 72 new claims were set up, according to Assistant Clerk Paula Woolums. Paula also dismissed four (4) claims for being under the \$100.00 threshold.

Investigators Jackie Lynch and Wanda Luttrell decided 28 claims (under \$1,000.00) in November, 2009. Jackie reports that 14 claims were dismissed and 14 claims were awarded, for a total amount awarded of \$4,413.37.

At its Board meeting on November 19, 2009, the Board dismissed 40 claims and awarded sixteen (16) claims totaling \$783,773.98. Together with the claims investigated in-house, the Board dismissed a total of 54 claims and awarded a total of 30 claims for a total amount awarded of \$788,187.35 in November, 2009.
