
# COMMONWEALTH OF KENTUCKY Board of Claims Agenda

December 17, 2010



The Board of Claims received 41 new claims during the month of November, 2010. A total of 41 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned one (1) subrogation claim for lack of jurisdiction and two (2) claims filed against non-state agencies.

Investigators Jackie Lynch and Wanda Luttrell decided 28 claims (under \$1,000.00) in November, 2010. Jackie reports that 17 claims were dismissed and 11 claims were awarded, for a total amount awarded of \$3,492.76.

At its Board meeting on November 18, 2010, the Board dismissed 29 claims and awarded eight (8) claims totaling \$37,409.00. Together with the claims investigated in-house, the Board dismissed a total of 46 claims and awarded a total of 19 claims for a total amount awarded of \$40,901.76 in November, 2010.
