Investigators Jackie Lynch and Wanda Luttrell decided 28 claims (under \$1,000.00) in November, 2010. Jackie reports that 17 claims were dismissed and 11 claims were awarded, for a total amount awarded of \$3,492.76.

At its Board meeting on November 18, 2010, the Board dismissed 29 claims and awarded eight (8) claims totaling \$37,409.00.
