# COMMONWEALTH OF KENTUCKY Board of Claims Agenda December 15, 2011



#### **REVISED MINUTES**

The Board of Claims received 60 new claims during the month of November, 2011. A total of 38 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned two (2) claims for lack of jurisdiction.

Investigators Jackie Lynch and Wanda Luttrell decided 49 claims (under \$1,000.00) in November, 2011. Jackie reports that 27 claims were dismissed and 22 claims were awarded, for a total amount awarded of \$8,655.69.

At its Board meeting on November 17, 2011, the Board dismissed 24 claims and awarded 12 claims totaling \$107,499.68. Together with the claims investigated in-house, the Board dismissed a total of 53 claims and awarded a total of 32 claims for a total amount awarded of \$116,155.37 in November, 2011.
