The Board of Claims received 46 new claims during the month of November, 2012. A total of 54 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned two (2) claims for lack of jurisdiction.

Investigator Jackie Lynch decided 26 claims under \$1,000.00 in November, 2012. Jackie reports that 17 of these claims were denied and nine (9) were awarded, for a total amount awarded of \$4,634.80.

At its Board meeting on November 15, 2012, the Board dismissed 10 claims and awarded 10 claims totaling \$16,994.45. Together with the claims investigated in-house, the Board dismissed a total of 27 claims and awarded a total of 19 claims for a total amount awarded of \$21,629.25 in November, 2012.
