At its Board meeting on November 20, 2014, the Board dismissed 15 claims and awarded 10 claims totaling \$26,608.20. Together with the claims investigated in-house, the Board dismissed a total of 22 claims and awarded a total of 23 claims for a total amount awarded of \$31,587.13 in November, 2014.
