The Board of Claims received 59 new claims during the month of November, 2015. Paula reports that 53 claims were set up and 2 were returned for lack of jurisdiction.

Investigator Jackie Lynch decided 36 claims under \$1,000.00 in November, 2015. Jackie reports that 15 of these claims were denied and 21 were awarded, for a total amount awarded of \$7,132.97.

At its Board meeting on November 19, 2015, the Board dismissed 28 claims and awarded eight (8) claims totaling \$12,141.75. Together with the claims investigated in-house, the Board dismissed a total of 43 claims and awarded a total of 29 claims for a total amount awarded of \$19,274.72 in November, 2015.
