The Kentucky Claims Commission received 20 negligence claims filed against the Commonwealth during the month of November, 2016. Paula reports that 24 claims were set up and two (2) were returned for lack of jurisdiction.

Investigator Angela Robertson decided 16 claims under \$1,000.00 in November, 2016. Angela reports that seven (7) of these claims were dismissed and nine (9) were awarded, for a total amount awarded of \$3,947.56.

At its meeting on November 29, 2016, the Kentucky Claims Commission dismissed seven (7) negligence claims and awarded four (4) negligence claims totaling \$21,127.49. Together with the claims investigated in-house, the Claims Commission dismissed a total of 14 negligence claims and awarded a total of 13 negligence claims for a total amount awarded of \$25,075.05 in November, 2016.
