COMMONWEALTH OF KENTUCKY

Claims Commission Agenda December 19, 2017 Minutes approved

The Kentucky Claims Commission received 53 negligence claims filed against the Commonwealth during the month of November, 2017. Since the staff that handles negligence claims was cut from three (3) to two (2) unexpectedly on November 13, 2017, as many claims as possible were set up and served on state agencies by the two (2) remaining staff persons.

Investigators Angela Robertson and Raymond Shields decided 28 claims under \$2,500.00 in November, 2017. Angela reports that 16 of these claims were denied and 12 were awarded, for a total amount awarded of \$7,857.01.

At its meeting on November 28, 2017, the Kentucky Claims Commission dismissed nine (9) negligence claims and awarded seven (7) negligence claims totaling \$10,842.95. Together with the claims investigated in-house, the Claims Commission dismissed a total of 25 negligence claims and awarded a total of 19 negligence claims for a total amount awarded of **\$18,699.96** in November, 2017.

Hart Terrell v. Transportation Cabinet, Department of Highways

Notes: Claimant filed for damage to his vehicle which was allegedly caused by a sunken manhole on outbound Richmond Road in Fayette County. The Claimant stated that the hole was five (5) inches deep and caused him \$916.64 in damages. The Claimant asserts that the Commonwealth is at fault because maintenance or repair had not been made and the area was clearly dangerous. The Respondent stated that the area in question was the responsibility of Lexington/Fayette County Urban Government and this claim was subsequently dismissed for lack of jurisdiction. The Claimant then requested a Full Commission Review and submitted additional information from LFCUG that the road in question is not a county maintained roadway. This subsequent information has been sent to the Respondent for a response.

Counsel's Recommendation: The Respondent states that the manhole cover that the Claimant hit is the responsibility of the Lexington-Fayette Urban County Government and not the Commonwealth. However, LFUCG contends that the storm sewer structure "belongs to the State" per the attached contract. For discussion.
