is of February 1, 2008, there were 51 active claims under \$1,000.00. Jackie Lynch decided 50 claims during the nonth of January. She has received answers for 11 active claims that are waiting on a decision. She is currently one reek ahead of the statutory 60 day deadline and there is no backlog.
