Investigators Jackie Lynch and Wanda Luttrell decided 55 claims (under \$1000.00) in December, 2008. They dismissed 34 claims and awarded 21 claims for a total amount of \$8,572.94. Together with the claims investigated in-house, the Board dismissed a total of 45 claims and awarded 28 claims for a total amount awarded of \$26,987.16 in December, 2008.
