February 18, 2010

The Board of Claims received 70 new claims during the month of January, 2010. A total of 84 claims were set up, according to Assistant Clerk Paula Woolums. Paula also dismissed six (6) claims for being under the \$100.00 threshold.

Investigators Jackie Lynch and Wanda Luttrell decided 59 claims (under \$1,000.00) in January, 2010. Jackie reports that 49 claims were dismissed and 10 claims were awarded, for a total amount awarded of \$2,623.68.

At its Board meeting on January 21, 2010, the Board dismissed 15 claims and awarded five (5) claims totaling \$4,288.46. Together with the claims investigated in-house, the Board dismissed a total of 74 claims and awarded a total of 15 claims for a total amount awarded of \$6,912.14 in January, 2010.


