The Board of Claims received 93 new claims during the month of January, 2011. A total of 80 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned seven (7) claims for lack of jurisdiction.

Investigators Jackie Lynch and Wanda Luttrell decided 42 claims (under \$1,000.00) in January, 2011. Jackie reports that 28 claims were dismissed and 14 claims were awarded, for a total amount awarded of \$6,860.47.

At its Board meeting on January 20, 2011, the Board dismissed 19 claims and awarded five (5) claims totaling \$39,488.00. Together with the claims investigated in-house, the Board dismissed a total of 47 claims and awarded a total of 19 claims for a total amount awarded of \$46,348.47 in January, 2011.
