## February 21, 2013

The Board of Claims received 50 new claims during the month of January, 2013. A total of 49 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned three (3) claims for lack of jurisdiction.

Investigator Jackie Lynch decided 34 claims under \$1,000.00 in January, 2013. Jackie reports that 23 of these claims were denied and eleven (11) were awarded, for a total amount awarded of \$3,681.28.

At its Board meeting on January 17, 2013, the Board dismissed nine (9) claims and awarded nine (9) claims totaling \$229,927.75. Together with the claims investigated in-house, the Board dismissed a total of 32 claims and awarded a total of 20 claims for a total amount awarded of \$233,609.03 in January, 2013.

At the meeting, the Executive Director gave a report on the status of the mailings to the Board members: Once all the kinks are worked out of the Crime Victims' Compensation Board e-mailings, the Board of Claims' meeting materials will also be e-mailed to the Board members. The goal is to have all meeting materials e-mailed to the Board members by the end of the year.
