January 2022 Monthly Report:

During the month of January 2022, the Board of Claims received **48** negligence claims filed against the Commonwealth.

The Board rendered **61** decisions in claims *under \$2,500.00* in January 2022. Of those, **26** were dismissed and **35** were awarded for a total amount awarded of **\$22,212.15**.

At its January 2022 meeting, the Board awarded an additional **3** claims from Agreed Orders of Settlement and awarded **2** claims based upon the Respondents’ Answers for a total of **\$15,701.66**. Together with the claims under \$2,500.00, the Board decided **70** claims altogether, while dismissing a total of **30** negligence claims and awarding a total of **40** negligence claims for a total amount awarded of **\$33,210.15** during the month.
