The Board of Claims received 49 new claims during the month of December, 2010. A total of 49 claims were set up according to Assistant Clerk Paula Woolums. Paula also returned four (4) claims for lack of jurisdiction.

Investigators Jackie Lynch and Wanda Luttrell decided 27 claims (under \$1,000.00) in December, 2010. Jackie reports that 19 claims were dismissed and 8 claims were awarded, for a total amount awarded of \$2,323.45.

At its Board meeting on December 17, 2010, the Board dismissed 18 claims and awarded 17 claims totaling \$311,447.55. Together with the claims investigated in-house, the Board dismissed a total of 27 claims and awarded a total of 25 claims for a total amount awarded of \$313,771.00 in December, 2010.

In 2010, the Board of Claims received 848 claims, dismissed 677 claims, and awarded 294 claims for a total amount awarded in 2010 of \$1,281,805.62.
