The Board of Claims received 50 new claims during the month of December, 2015. Paula reports that a total of 58 claims were set up and four (4) claims were returned for lack of jurisdiction.

Investigator Jackie Lynch decided 48 claims under \$1,000.00 in December, 2015. Jackie reports that 26 of these claims were denied and 22 were awarded, for a total amount awarded of \$8,414.61.

At its Board meeting on December 17, 2015, the Board dismissed 10 claims and awarded seven (7) claims totaling \$26,337.39. Together with the claims investigated in-house, the Board dismissed a total of 36 claims and awarded a total of 33 claims for a total amount awarded of \$34,752.00 in December, 2015.
