January 24, 2017

The Kentucky Claims Commission received 40 negligence claims filed against the Commonwealth during the month of December, 2016. Paula reports that 31 claims were set up.

Investigator Angela Robertson decided 20 claims under \$1,000.00 in December, 2016. Angela reports that 12 of these claims were dismissed and eight (8) were awarded, for a total amount awarded of \$2,688.66.

At its meeting on December 13, 2016, the Kentucky Claims Commission dismissed four (4) negligence claims and awarded three (3) negligence claims totaling \$10,730.50. Together with the claims investigated in-house, the Claims Commission dismissed a total of 16 negligence claims and awarded a total of 11 negligence claims for a total amount awarded of \$13,419.16 in December, 2016.
