December 2021 Monthly Report:

During the month of December 2021, the Board of Claims received **45** negligence claims filed against the Commonwealth.

The Board rendered **50** decisions in claims *under* \$2,500.00 in December 2021. Of those, **31** were dismissed and **19** were awarded for a total amount awarded of **\$10,141.67**.

At its December 2021 meeting, the Board awarded an additional **3** claims from Agreed Orders of Settlement, affirmed **2** claims upon Full Board Review where the claim was dismissed, and **9** additional claims were dismissed either from Agreed Orders of Dismissal, via Motions from the parties, or via Recommended Orders. Together with the claims under \$2,500.00, the Board decided **62** claims altogether, while dismissing a total of **40** negligence claims and awarding a total of **22** negligence claims for a total amount awarded of **\$17,508.49** during the month.
