Board of Claims Agenda

July 15, 2010

The Board of Claims received 72 new claims during the month of June, 2010. A total of 82 claims were set up, according to Assistant Clerk Paula Woolums. Paula also dismissed three (3) claims for being under the \$100.00 threshold and returned six (6) non-jurisdictional claims.

Investigators Jackie Lynch and Wanda Luttrell decided 68 claims (under \$1,000.00) in June, 2010. Jackie reports that 35 claims were dismissed and 33 claims were awarded, for a total amount awarded of \$13,397.80.

At its Board meeting on June 17, 2010, the Board dismissed 16 claims and awarded five (5) claims totaling \$4,874.28. Together with the claims investigated in-house, the Board dismissed a total of 51 claims and awarded a total of 38 claims for a total amount awarded of \$18,272.08 in June, 2010.
