The Board of Claims received 65 new claims during the month of June, 2014. A total of 60 claims were set up according to Assistant Clerk Paula Woolums. Paula also reports that one (1) claim was returned for lack of jurisdiction.

Investigator Jackie Lynch decided 37 claims under \$1,000.00 in June, 2014. Jackie reports that 23 of these claims were denied and 14 were awarded, for a total amount awarded of \$6,666.38.

At its Board meeting on June 19, 2014, the Board dismissed 21 claims and awarded 16 claims totaling \$152,698.99. Together with the claims investigated in-house, the Board dismissed a total of 44 claims and awarded a total of 30 claims for a total amount awarded of \$159,365.37 in June, 2014.
