The Board of Claims received 83 new claims during the month of June, 2015. Paula reports that 105 claims were set up and three (3) were returned for lack of jurisdiction.

Investigator Jackie Lynch decided 105 claims under \$1,000.00 in June, 2015. Jackie reports that 56 of these claims were denied and 49 were awarded, for a total amount awarded of \$16,954.83.

At its Board meeting on June 18, 2015, the Board dismissed seven (7) claims and awarded six (6) claims totaling \$160,014.00. Together with the claims investigated in-house, the Board dismissed a total of 63 claims and awarded a total of 55 claims for a total amount awarded of \$176,968.83 in June, 2015.
