# **COMMONWEALTH OF KENTUCKY** Claims Commission Agenda

July 25, 2017

The Kentucky Claims Commission received 59 negligence claims filed against the Commonwealth during the month of June, 2017. Paula reports that 59 claims were set up and two (2) claims were returned for lack of jurisdiction.

Investigator Angela Robertson decided 19 claims under \$1,000.00 in June, 2017. Angela reports that 11 of these claims were denied and eight (8) were awarded, for a total amount awarded of \$2,973.95.

At its meeting on June 20, 2017, the Kentucky Claims Commission dismissed two (2) negligence claims and awarded nine (9) negligence claims totaling \$54,017.00. Together with the claims investigated in-house, the Claims Commission dismissed a total of 13 negligence claims and awarded a total of 17 negligence claims for a total amount awarded Apreciation for faule's years of Service. of \$56,990.95 in June, 2017.

# REQUESTS FOR COMMISSION REVIEW (f/k/a Full Board Review):

## BC-2016-602

James Richard v. Justice & Public Safety Cabinet / Dept. of Corrections

Notes: Mr. Richard filed a claim for property stolen from a secure location. The total damages claimed \$214.05. The Claimant stated that the guard opened his cell for his television, remote and headphones to be stolen on May 16, 2016. The Respondent stated that the theft was not reported until September 15, 2016 when the Claimant filed a grievance. The Respondent reviewed the records and does not show that guards opened the Claimant's cell on May 16, 2016. The Claimant did not prove the loss was due to the negligence of the Respondent and the claim was dismissed. The Claimant requested a full

board review and submitted additional information. A property form from December 2015 showing that he had a television in his possession at that time and one from September 2016 showing he did not have a television in his possession at that time. He stated that a theft report was filed on May 16, 2016 but did not submit a copy of this report. He also stated that the guard can use a key to open the cells so he questions if that would show up on the electronic report. The Claimant has not provided evidence that the Respondent was negligent, request this claim be dismissed.

#### BC-2016-645

Jason Cline v. Justice & Public Safety Cabinet / Dept. of Corrections

Notes: The Claimant has filed a claim for missing property totaling \$216.96. The Claimant stated his property was stolen after being beat up by three other inmates. The claimant stated the Commonwealth is at fault because the control center was not watching the cameras. The Respondent stated the Claimant is in a four wing building with 152 inmates. Each wing has one guard assigned for each shift who is responsible for making rounds and doing cell searches. The control center does not watch the cameras they are reviewed during investigations. Inmates will block the cameras or disguise themselves so they cannot be identified on camera. The property room was checked for the missing items but were not located. The Respondent stated that KRS cannot be responsible for property that was not in their possession. The Claimant stated that his television and "canteen items" were stolen but did not provide a list of what those canteen items were. The theft report for the incident was also not submitted. Negligence could not be found on part of the Respondent. The Claimant submitted a Full Board Review and has submitted a list of stolen canteen items but states that the theft report was never properly filed by KSR staff Evidence of the theft and proof of negligence has not been provided. Recommend the dismissal of the claim be upheld.
