# COMMONWEALTH OF KENTUCKY Claims Commission Minutes July 23, 2019

The Kentucky Claims Commission received **62** negligence claims filed against the Commonwealth during the month of June, 2019.

The Claims Commission processed and/or decided **72** claims under \$2,500.00 in June, 2019. Twenty-one (21) of these claims were dismissed and 51 were awarded, for a total amount awarded of **\$28,628.72**.

At its meeting on June 25, 2019, the Kentucky Claims Commission dismissed five (5) negligence claims and awarded two (2) negligence claims. Together with the claims investigated in-house, the Claims Commission dismissed a total of 26 negligence claims and awarded a total of 53 negligence claims for a total amount awarded of **\$35,628.72** in June, 2019.

The minutes of the June 25, 2019 meeting of the Kentucky Claims Commission, Negligence Claims, were approved.
