I. JUNE MONTHLY REPORT

During the month of June 2024, the Board of Claims received **73** negligence claims filed against the Commonwealth.

The Board rendered **86** decisions in claims *under \$2,500.00* in June 2024. Of those, **46** were dismissed and **40** were awarded for a total amount awarded of **\$29,102.06**.

At its June meeting, the Board affirmed **2** claims upon Full Board Review, dismissed **8** claims upon Motions or *sua sponte* dismissals, granted **3** Agreed Orders of Dismissal, and entered **2** Final Orders, awarding an additional amount of **\$66,460.00**. With the claims under \$2,500.00, and those decided at the June Meeting, the Board decided **101** claims, dismissing a total of **55** claims, and awarding a total of **46** claims for a total amount awarded of **\$95,562.06**.
