I. JUNE MONTHLY REPORT

During the month of June, the Board of Claims received **101** negligence claims filed against the Commonwealth.

The Board rendered **82** decisions in claims *under \$2,500.00* in June 2025. Of those, **33** were dismissed and **49** were awarded for a total amount awarded of **\$29,248.49**.

At its June meeting, the Board affirmed **1** claim upon Full Board Review, passed **1** motion, granted **1** motion, dismissed **14** claims for failure to respond to Show Cause Orders, and awarded **3** claims through Agreed Orders of Dismissal, awarding an additional amount of **\$9,441.00**. With the claims under \$2,500.00, and those decided at the June Meeting, the Board decided **100** claims, dismissing a total of **48** claims, and awarding a total of **52** claims for a total amount awarded of **\$38,689.49**.
