COMMONWEALTH OF KENTUCKY Board of Claims Agenda

June 17, 2010

The Board of Claims received 90 new claims during the month of May, 2010. A total of 68 claims were set up, according to Assistant Clerk Paula Woolums. Paula also dismissed two (2) claims for being under the \$100.00 threshold and returned eight (8) non-jurisdictional claims.

Investigators Jackie Lynch and Wanda Luttrell decided 65 claims (under \$1,000.00) in May, 2010. Jackie reports that 43 claims were dismissed and 22 claims were awarded, for a total amount awarded of \$7,249.67.

At its Board meeting on May 20, 2010, the Board dismissed 32 claims and awarded 13 claims totaling \$415,692.18. Together with the claims investigated in-house, the Board dismissed a total of 75 claims and awarded a total of 35 claims for a total amount awarded of \$422,941.85 in May, 2010.
