The Board of Claims received 130 new claims during the month of May, 2011. A total of 99 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned two (2) claims for lack of jurisdiction.

Investigators Jackie Lynch and Wanda Luttrell decided 61 claims (under \$1,000.00) in May, 2011. Jackie reports that 23 claims were dismissed and 38 claims were awarded, for a total amount awarded of \$15,240.32.

At its Board meeting on May 19, 2011, the Board dismissed 19 claims and awarded 10 claims totaling \$61822.34. Together with the claims investigated in-house, the Board dismissed a total of 42 claims and awarded a total of 48 claims for a total amount awarded of \$77,062.66 in May, 2011.
