
COMMONWEALTH OF KENTUCKY

Board of Claims Agenda

June 21, 2012



The Board of Claims received 53 new claims during the month of May, 2012. A total of 38 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned four (4) claims for lack of jurisdiction.

Investigators Jackie Lynch and Wanda Luttrell decided 29 claims under \$1,000.00 in May, 2012. Jackie reports that 22 of these claims were dismissed and nine (9) were awarded, for a total amount awarded of \$3,366.00.

At its Board meeting on May 17, 2012, the Board dismissed 16 claims and awarded five (5) claims totaling \$19,152.42. Together with the claims investigated in-house, the Board dismissed a total of 38 claims and awarded a total of 14 claims for a total amount awarded of \$22,518.42 in May, 2012.
