I. May 2022 Monthly Report:

During the month of May 2022, the Board of Claims received 93 negligence claims filed against the Commonwealth.

The Board rendered **59** decisions in claims *under \$2,500.00* in May 2022. Of those, **24** were dismissed and **35** were awarded for a total amount awarded of **\$23,709.65**.

At its May 2022 meeting, the Board approved **8** Agreed Orders of Dismissal, awarding an additional **\$75,400**. Together with the claims under \$2,500.00, the Board decided **79** claims, awarding a total of **32** claims, and dismissing a total of **55** claims, the total amount awarded being **\$99,109.65**.
