I. MAY MONTHLY REPORT

During the month of May, the Board of Claims received **154** negligence claims filed against the Commonwealth.

The Board rendered **82** decisions in claims *under \$2,500.00* in May 2025. Of those, **48** were dismissed and **34** were awarded for a total amount awarded of **\$18,970.50**.

At its May meeting, the Board vacated **2** claims upon Full Board Review but assigned **1** of those to a hearing officer and allowed the other to proceed also, overruled **1** motion, dismissed **2** claims via Motions and *sua sponte* dismissals, and awarded **3** claims through Agreed Orders of Dismissal and entry of Final Orders, awarding an additional amount of **\$9,104.74**. With the claims under \$2,500.00, and those decided at the May Meeting, the Board decided **88** claims, dismissing a total of **51** claims, and awarding a total of **37** claims for a total amount awarded of **\$28,075.24**.
