June 24, 2025 Meeting

MINUTES

The meeting, conducted via Microsoft Teams, was called to order at approximately 10:10 am., and the following business was conducted in Board of Claims matters.

In attendance were Board Members Samuel Wright, Kathryn Thomas, and Dale Sights. Chairman Wright called the meeting to order. A quorum existed and business was conducted.

Also in attendance were: Executive Director John Hardesty, Staff Attorneys Shelby Bevins-Sullivan and Linda Horsman, Clerk Katie Dean, Attorney James O'Toole for Claimants Benjamin Jones and Diane Lamb, and Claimant Delaina Wilson.

After Director Hardesty delivered the monthly report for the Board of Claims for May 2025, the May Minutes were approved. Vice Chair Thomas moved to approve the May Minutes with Member Sights seconding. Having all in favor, the Motion carried.

After the Board approved the May Minutes, the following claims were taken up for consideration:
