The Board of Claims received 143 new claims during the month of February, 2011. A total of 81 claims were set up, according to Assistant Clerk Paula Woolums. Five (5) claims were returned by Paula for lack of jurisdiction.

Investigators Jackie Lynch and Wanda Luttrell decided 38 claims (under \$1,000.00) in February, 2011. Jackie reports that 32 claims were dismissed and six (6) claims were awarded, for a total amount awarded of \$1,651.58.

At its Board meeting on February 17, 2011, the Board dismissed 17 claims and awarded five (5) claims totaling \$29,947.37. Together with the claims investigated in-house, the Board dismissed a total of 49 claims and awarded a total of 11 claims for a total amount awarded of \$31,598.95 in February, 2011.
