The Board of Claims received 57 new claims during the month of February, 2012. A total of 33 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned two (2) claims for lack of jurisdiction.

Investigators Jackie Lynch and Wanda Luttrell decided 34 claims under \$1,000.00 in February, 2012. Jackie reports that 22 of these claims were dismissed and 12 were awarded, for a total amount awarded of \$4,833.02.

At its Board meeting on February 16, 2012, the Board dismissed 19 claims and awarded six (6) claims totaling \$31,400.00. Together with the claims investigated in-house, the Board dismissed a total of 53 claims and awarded a total of 18 claims for a total amount awarded of \$36,233.02 in February, 2012.

The Executive Director informed the Board about her on-air interview with investigative reporter Duane Pohlman of WLKY on pot holes and our process and responsibilities. The Director wanted the Board to know and be complimented by how hard the Board staff worked to gather and provide the background information, understanding the sore deficiencies of our current tracking system.
