The Board of Claims received 78 new claims during the month of February, 2014. A total of 73 claims were set up, according to Assistant Clerk Paula Woolums. Paula also reports that two (2) claims were returned for lack of jurisdiction.

Investigator Jackie Lynch decided 30 claims under \$1,000.00 in February, 2014. Jackie reports that 17 of these claims were denied and 13 were awarded, for a total amount awarded of \$6,033.82.

At its Board meeting on February 20, 2014, the Board dismissed 21 claims and awarded 14 claims totaling \$55,511.97. Together with the claims investigated in-house, the Board dismissed a total of 38 claims and awarded a total of 27 claims for a total amount awarded of \$61,545.79 in February, 2014.
