The Board of Claims received 34 new claims during the month of February, 2015. Paula reports that a total of 40 claims were set up and two (2) claims were returned for lack of jurisdiction.

Investigator Jackie Lynch decided 26 claims under \$1,000.00 in February, 2015. Jackie reports that 14 of these claims were denied and 12 were awarded, for a total amount awarded of \$6,675.45.

At its Board meeting on February 26, 2015, the Board dismissed 13 claims and awarded four (4) claims totaling \$5,646.82. Together with the claims investigated in-house, the Board dismissed a total of 27 claims and awarded a total of 16 claims for a total amount awarded of \$12,322.27 in February, 2015.
