The Board of Claims received 70 new claims during the month of February, 2016. Paula reports that a total of 47 claims were set up and four (4) claims were returned for lack of jurisdiction.

Investigator Jackie Lynch decided 30 claims under \$1,000.00 in February, 2016. Jackie reports that 25 of these claims were denied and five (5) were awarded, for a total amount awarded of \$2,334.55.

At its Board meeting on February 18, 2016, the Board dismissed 27 claims and awarded four (4) claims totaling \$184,246.21. Together with the claims investigated in-house, the Board dismissed a total of 52 claims and awarded a total of nine (9) claims for a total amount awarded of \$186,580,76 in February, 2016.
