# COMMONWEALTH OF KENTUCKY CLAIMS COMMISSION Agenda March 28, 2017

The Kentucky Claims Commission received 42 negligence claims filed against the Commonwealth during the month of January, 2017. Paula reports that 45 claims were set up and three (3) claims were returned for lack of jurisdiction.

Investigator Angela Robertson decided 17 claims under \$1,000.00 in February, 2017. Angela reports that 11 of these claims were dismissed and six (6) were awarded, for a total amount awarded of **\$1,021.66**.

At its meeting on February 21, 2017, the Kentucky Claims Commission dismissed seven (7) negligence claims and awarded four (4) negligence claims totaling \$7,591.33. (An award of \$8,797.42 in Claim No. BC-09-612, Tussey v. Dept. of Natural Resources, ordered by the former Board of Claims in 2012, was reinstated by the Commission upon remand by the Kentucky Court of Appeals.) Together with the claims investigated in-house, the Claims Commission dismissed a total of 18 negligence claims and awarded a total of 10 negligence claims for a total amount awarded of **\$8,612.99** in February, 2017.

Notes: Mr. Ritter filed a claim for \$306.28 regarding stolen property from his cell. Claimant stated negligence because EKCC knew who stole his property but did nothing to recover the property. The Respondent provided documentation that the

inmate that stole the property has been found guilty and ordered to pay restitution of \$284.62. Totaling receipts provided and factoring in depreciation on the television the total that would be considered by the Claims Commission would be \$261.67 which is less than the restitution awarded so there is no outstanding balance to consider. The Commission's Investigator, Angela Robertson, recommends upholding dismissal of uphold this claim.
