February 2022 Monthly Report:

During the month of February 2022, the Board of Claims received **92** negligence claims filed against the Commonwealth.

The Board rendered **36** decisions in claims *under \$2,500.00* in February 2022. Of those, **18** were dismissed and **18** were awarded for a total amount awarded of **\$14,229.65**

At its February 2022 meeting, the Board awarded an additional **6** claims from Agreed Orders of Settlement for a total of **\$54,930.91**. Together with the claims under \$2,500.00, the Board decided **47** claims altogether, while dismissing a total of **23** negligence claims and awarding a total of **24** negligence claims for a total amount awarded of **\$69,150.56** during the month.
